1. Apologies

None.

2. Climate and Environment Symposium 2024

John Tiffany, a Flood Warden and member of the Friends of the Gumstool Brook, provided an overview of the proposed Climate and Environment Symposium. The symposium was conceived by the Friends of the Gumstool Brook, who expressed their interest in organising a conference. The Town Council's CEO assisted the Friends of Gumstool Brook in obtaining funding from the Winstone Trust to host a one-day conference at the Royal Agricultural University in Spring 2024. There is now a working sub-group with representatives from the Town Council

The symposium aims to invite keynote speakers who are knowledgeable on local issues and climate change. In the morning, keynote speakers will share their knowledge on the topic, followed by breakout sessions in the afternoon to brainstorm potential solutions to the issues at hand. The conference will conclude with a feedback session.

The Group expressed their appreciation to John for his attendance and reporting of the conference. They agreed it was an excellent initiative. The central point of discussion was the intended audience and the need to get the right people present. Discussion included identifying local landowners, and contacting stakeholders from local organisations such as parish councils, Gloucestershire Wildlife Trust, the Cotswold National Landscape, and students from the Royal Agricultural University and Cirencester College. It was also agreed the symposium needs specific, and clearly communicated, aims and outcomes.

3. Declarations of Interest

4. Notes of the Meeting of the Climate Change Advisory Group

Members received and approved the notes of the previous Climate Change Advisory Group meeting held on Tuesday 20th June 2023, noting a correction to the name of Chris Crookall-Fallon.



5. Climate and Environment Action Plan 2023-24

The Lead Officer provided an overview of the latest updates to the Action Plan. It was agreed that the commitment to becoming carbon neutral by 2030 (Item 5) should have some interim targets set by the next meeting.

6. Climate and Environment Competition

The group discussed the documents that were prepared and circulated by the Lead Officer. The focus of the discussion centered on potential judges for the project. The Group identified several interested individuals and organisations which include representatives from Vision 21, Severn Wye, Sustrans, Glos Wildlife Trust Youth Advisory Group, and a member of the Youth Parliament. It was agreed that the judging panel should consist of a maximum of 5 judges.

The launch date and timetable were also discussed. The Lead Officer will prepare a draft timetable and present it for approval in the next meeting.

It was agreed that the language used to advertise the competition will be changed to reflect the idea of "bringing your environmentally friendly ideas to fruition" rather than "raising awareness." Additionally, the hashtag #CirenClimateComp will be used to promote the competition. It was also noted Information will be sent to ward councilors, with links to the relevant documents, prior to the launch.

Clarification was provided that the competition does not require anyone to spend money upfront, just to submit creative ideas on a climate/environmental theme,

and acting to reduce the organisations carbon footprint.

from this report, equality and diversity has to be a core consideration as we consider the wider response to the climate emergency and an inclusive response to ensuring that everyone in our community has access to, empowered to and provided with support and resources to

reduce their carbon footprint.

RECOMMENDATION: That the Road Map draft outline be approved for consultation with

staff and elected members.

1. BACKGROUND

- 1.1 At the full meeting of Cirencester Town Council on 12 July 2019, the Council declared that Climate Change is an Emergency that requires urgent and comprehensive action, from individuals to businesses to all levels of governance, and passed a motion in support of this position.
- 1.2 To facilitate the reduction of its carbon emissions, Cirencester Town Council resolves to:
 - 1.2.1 commit to becoming a carbon-neutral organisation by 2030, to include scope 1, 2 and 3 emissions;
 - 1.2.2 achieve 100% clean energy use across the council's land and buildings, rented or owned, by December 2020;
 - 1.2.3 support, in principle, Cirencester to reduce direct and indirect CO₂ emissions and become resilient to changes caused by the changing climate.
- 1.3 In particular, the Council will be encouraging the:
 - 1.3.1 use of sustainable transport;
 - 1.3.2 reduction of energy use in homes, businesses and elsewhere;
 - 1.3.3 co-operation of organisations seeking to develop low carbon and community-led affordable housing in Cirencester;
 - 1.3.4 use and development of renewable energy sources;
 - 1.3.5 production, sale and consumption of locally-sourced food;
 - 1.3.6 minimisation of air travel.
- 1.4 In declaring a climate emergency the Town Council acknowledged the Intergovernmental Panel on Climate Change (IPCC) special report dated October 2018 on the subject of 'Global Warming of 1.5°C'. The report stated that:
 - 1.4.1 human activity has already caused 1°C of warming to the earth;
 - 1.4.2 to limit warming to 1.5°C, it will be necessary to halve global carbon emissions by 2030 and to achieve near-zero net emissions by 2050;
 - 1.4.3 the consequences of 2°C warming is significantly worse than 1.5°C warming across all areas considered in the report.
- 1.5 Extreme weather events happening now can be attributed with confidence to warming at this scale, and the impacts of climate breakdown are already causing serious damage around the world. The UK faces damaging local impacts related to extreme heat, water shortages, sea level rise, and global impacts such as food price shocks and greatly increased migratory pressures. Therefore, we all have responsibility and accountability for change.

2. PURPOSE OF REPORT

- 2.1 The role and remit of the Climate and Environment Committee includes initiating and overseeing the process of Cirencester Town Council becoming a carbon neutral organisation as soon as possible before 2030; the purpose of this report is to scope how that will be achieved.
- 2.2 Whilst noting the 2030 target, the Committee should be mindful of the carbon and sustainability targets recommended through the 2021-22 carbon footprint report noting that "organisations are now setting targets based on the Science

Based Target initiative. Typical targets cover midterm and longer terms goals such as: a 50% reduction in emissions per employee by 2030 and a 90% reduction in emissions per employee by 2045. All targets set should be reviewed regularly and amended accordingly. A clear road map for individual emissions sources should be in place. This will ensure the strategy for reducing CO2e emissions and tracking toward a net zero target is appropriate for the business."

3. DECARBONISATION

- 3.1 The terminology used by the Council has determined that as an organisation we are working to carbon neutrality; this term is interchangeable with that of net zero. The simplest definition being that through what we do as individuals within, and as an organisation we are reducing and eventually eliminating CO2 emissions.
- 3.2 Our starting point has been to measure our carbon footprint; however, the measures we have used have not been exhaustive and we acknowledge that data collection needs to be more reliable. Year on year we are building this evidence base, increasing the range of measures and improving the data collection.
- 3.3 Our carbon footprint is a measure of the impact we have on global warming. This is our human-made impact on global warming. How many CO2 emissions are generated as a result of our activity as an organisation which has a detrimental, destabilizing and unnatural impact on our climate.
- 3.4 In addition to CO2 emissions, we need to be aware that other emissions are equally if not of greater detriment to our natural climate and environment, such as methane, emitted by agriculture and landfill sites and nitrous-oxide released through industrial and farming processes.
- 3.5 These emissions are referred to as greenhouse gases. Greenhouse gases emitted into the atmosphere cause the earth to increase in temperature, this causes the climate to change and creates a greater risk to extreme weather.
- 3.6 A single, simple, item or activity can be made or result in the release of multiple greenhouse gases into the atmosphere.
- 3.7 Measuring our carbon-footprint as individuals and an organisation is complex.

 From the energy used, to the vehicles, equipment and machinery needed to deliver services to the public to the technology purchased to enable us to do our job and function as a business.
- 3.8 There are 'direct' and 'indirect' emissions.
- 3.9 Take a simple plastic pen, the carbon footprint starts even before manufacturing, and is calculated through the manufacturing process through the supply chain to the Town Council as the consumer; and that's not where the footprint ends, to what extent does the pen have a life-cycle and what is the footprint of disposal.
- 3.10 This why the simple message of 'reduce', 'reuse', 'repurpose' and, 'recycle' is so important alongside 'refuse' refusing, as far as is possible to buy plastic in the first place.

4. ROAD MAP

- 4.1 The Town Council's Climate and Environment Committee has an approved an action plan, which outlines our own initial response as an organisation to the climate emergency and how we will work with, and encourage, others in acting.
- 4.2 Incorporated within the Action Plan is the Town Council's response to working towards carbon neutrality.
- 4.3 This requires separate planning and focus; it is proposed that we consider and adopt a road map outlining the key milestones in action planning and delivery.
- 4.4 A Road Map will be prepared for consideration at the Staff and Member Networking Lunch and the Lead Member/Lead Officer briefing session to be held on Tuesday 28th November; the draft outline is as follows (Q1. January to March, Q2. April to June, Q3. July to September, Q4. October to December):

Climate and Environment Action Plan 2023-24





In 2019, Cirencester Town Council declared a Climate Emergency; this is because the Council acknowledged that the Intergovernmental Panel on Climate Change (IPCC) released a special report in October 2018 on the subject of 'Global Warming of 1.5°C'.

The report stated that:

- human activity has already caused 1°C of warming to the earth;
- to limit warming to 1.5°C, it will be necessary to halve global carbon emissions by 2030 and to achieve near-zero net emissions by 2050;
- the consequences of 2°C warming is significantly worse than 1.5°C warming across all areas considered in the report.

Extreme weather events happening now can be attributed with confidence to warming at this scale, and the impacts of climate breakdown are already causing serious damage around the world. The UK faces damaging local impacts related to extreme heat, water shortages, sea level rise, and global impacts such as food price shocks and greatly increased migratory pressures.

The Climate Change Advisory Group has already made good progress in starting to audit and benchmark the Council's carbon footprint, the leasing of vehicles and equipment, banking arrangements and investments and switching energy tariffs.

We have also significantly minimised the number of in person meetings and have introduced flexible arrangements for working from home, reducing the need to travel. Our Council and Committee meetings are now streamed live via YouTube, reducing the need for members of the public to physically travel to our meetings.

We are also printing less and using less plastic; thinking more about how we can re-use and recycle. Our open spaces are also important for bio-diversity as well as contributing positively to the climate, this means less manicuring and more appropriate management with partners such as the Gloucestershire Wildlife Trust.

- **4. Sustainability**: The judges will assess how the project will cope with ongoing costs, such as maintenance, and whether the project's long-term existence is sustainable. The applicants should have a clear plan on how to meet and manage these costs and any permissions needed to successfully launch their idea.
- **5. Collaboration:** The judges will weight proposals that involve the community and demonstrate partnerships between groups, businesses, or organisations.

Who can enter

Local communities, groups, and individuals of all ages are encouraged to submit their ideas.

Improvements or additional features to existing projects that fit the competition themes can also be submitted.
